### SHOW CAUSE NOTICE

Mr. Mohammad Juned (S/o Mr. Mr. Mohd Jafar), aged 21 years, residing at House No.32, Chak No.22, Tehsil Tanda, Maholla-Bhabhalpuri, Rampur, Tanda Badli, Uttar Pradesh 244925 (hereinafter referred to as the "passenger"), arrived at SVP International Airport, Ahmedabad from Delhi by Air India Flight No. AI 019 on 12.02.2020, as a domestic passenger. On suspicious movement of Mr. Mohammad Juned, he was intercepted by the AIU officers (hereinafter referred to as the "officers") when he was about to exit the arrival hall through the Green Channel area. Personal search and detailed examination was carried out in presence of panchas.

2. The passenger was found carrying one grey coloured back pack bag. The passenger was asked whether he was carrying any metallic substance, to which he denied. He was asked to walk through the Door Framed Metal Detector (DFMD) after removing all metallic substances from his body such as mobile, wallet etc. While he walked through the DFMD, no beep sound was heard indicating there was nothing objectionable/dutiable on his body/clothes. Thereafter, the backpack bag of Mr. Mohammad Juned was scanned in the X-ray bag scanning machine (BSM) located near the green channel counter at terminal 2 of SVPI Ahmedabad. An unusual image was noticed by the officers on the screen of baggage screening machine. On suspicion, the officers examined the bag and its contents in detail and found one packet wrapped in plastic. On opening the packet by cutting the adhesive tape, yellow metal substance in the form of 08 gold bars and 02 cut pieces of gold bars were recovered from the possession of Mr. Juned.

3. Whereas, Mr Mohammad Juned along with his bag was brought in the office of Air Intelligence Unit in the Arrival Hall of SVPI Airport Ahmedabad for further interrogation. On being asked, the passenger informed that the said 08 gold bars and 02 cut pieces wrapped with brown adhesive tape in one packet were handed over to him by one international passenger named Jishan Alam having Indian Passport No.M960101 who had arrived from Kuwait to Ahmedabad by Jazeera Airways Flight No.J9 407 on 12.02.2020 at 06.00 hours. He further informed that he collected the packet containing the said gold bars from the international passenger i.e Mr. Jishan Alam near the stairs located in the immigration area of Terminal 2 building of SVP International Airport, Ahmedabad after arriving from Delhi to Ahmedabad by Air India Flight No.AI 019 at 06.40 hours. He further informed that Mr. Jishan Alam left the Airport through the exit gate. He also admitted that they knew each other for last two years and
