SHOW CAUSE NOTICE

Whereas, M/s. Zydus Healthcare Limited having their registered office at Zydus Tower, Satellite Cross Road, Ahmedabad (here-in-after referred to as "M/s. Zydus" or "the said importer" having GSTIN No. 24AAACG1895Q1Z4 and IEC No. 0389057274 had executed Bond and submitted Bank Guarantee against the same for procurement of the goods viz.
