ORDER UNDER SECTION 110 (1) AND (3) OF THE CUSTOMS ACT, 1962

In exercise of power conferred under sub-section (1) of Section 110 of the Customs Act, 1962, I, the undersigned, order to place 24Kt Gold Kada and Gold Kadiwali Chain totally weighing 186.070 Grams having purity 999.0 valued at ; **Tariff valued at Rs. 6,62,595 [Tariff Value] (Rupees Six Lakh sixty two thousand thousand five hundred and ninety five Only) and Market Valued at Rs. 7,80,192/- [(Market Value)] (Rupees Seven Lakh eighty thousand one hundred and ninety two only)**as on 28.01.2020 smuggled Mr. Nirav Mukesh Pithawa under seizure on the reasonable belief that the said goods are liable for confiscation under Section 111 of the Customs Act, 1962, due to the reason that the said goods have been attempted to be smuggled into India through SVPI Airport, Ahmedabad by Mr. Nirav Mukesh Pithawa in form of Gold Kada and Gold Kadiwali Chain and same were recovered during the course of Panchnama dated 28.01.2020 drawn at SVPI Airport, Ahmedabad.

2. The gold which was recovered from Mr. Nirav Mukesh Pithawa is being seized as under:
