ORDER UNDER SECTION 110 (1) AND (3) OF THE CUSTOMS ACT, 1962

In exercise of power conferred under sub-section (1) of Section 110 of the Customs Act, 1962, I, the undersigned, order to place 24Kt Gold Kada and Gold Kadiwali Chain totally weighing 250 grams having purity 999.0 valued Tariff value Rs. 9,16,300/- (Rupees Nine Lakh Sixteen thousand three hundred Only) and Market Value Rs. 10,50,000/- (Rupees Ten Lakh Fifty thousand only) as on 07.02.2020 smuggled by Mr. Dhan Pal Kalal under seizure on the reasonable belief that the said goods are liable for confiscation under Section 111 of the Customs Act, 1962, due to the reason that the said goods have been attempted to be smuggled into India through SVPI Airport, Ahmedabad by Mr. Dhan Pal Kalal in form of Gold Kada and Gold Kadiwali Chain and same were recovered during the course of Panchnama dated 07.02.2020 drawn at SVPI Airport, Ahmedabad.

2. The gold which was recovered from Mr. Dhan Pal Kalal is being seized as under:

Further, in exercise of powers conferred under sub-section (3) of Section 110 of the Customs Act, 1962, I, undersigned, order to place one 24 Kt. Gold Kada and one 24 Kt. Gold Kadiwali Chain, under seizure on reasonable belief that the same were attempted to be smuggled into India in violation of Section 77, Section 132 and Section 135, of the Customs Act, 1962.
