Sr. No	Particulars of work	Specification
1	Overhead Storage Units (Customized)	Overhead wooden storage by using 18mm thick plywood with 1mm thick laminate. The overhead storage shall be provided with handles (Stainless Steel finish) and standard locks. All exposed plywood surfaces to be finished with 1mm thick laminate of approved make & shade. All wood used shall be teakwood. Total area of overhead storage is 650sq. ft.(Approx). The quoted rate should be per square ft.
2.	Electric work (wherever required)	1. MV switches and power panels 2. Distribution boards. 3. MV cabling. 4. Cable Termination. The quoted rate should be per electric point.
