### TERMS & CONDITIONS:-

1. Quotations are invited from authorized dealers, suppliers or manufacturers. Hence, Authorization/ Manufacturer Certificate duly attested by the authorized signatory of the firm should be attached with the quotation. The quotations without said certificate will be summarily rejected.
2. A general undertaking that all terms and conditions of this Bid Document are acceptable in the format placed at Annexure-A to this document. This needs to be signed by an authorized person of the applying firm.
3. Further, the party should furnish their compliance sheet as per Annexure-B.
4. The price of new air conditioner should be quoted in prescribed proforma as per Annexure-C in separate sealed cover. **The Price Quoted should not exceed Maximum Retail Price (MRP) and should be inclusive of all taxes, incidental charges, insurance charges, freight etc. with free installation.**
5. The quotations in sealed cover should be marked as **“QUOTATION FOR SPLIT AIR CONDITIONERS”** and addressed to The Additional Commissioner (P&V), Customs, Ahmedabad on above mentioned address.
6. **The last date for submission of quotations is 18.08.2016 till 15:00 Hrs.** Quotations received after the said date & time will be summarily rejected.

7. The quotation must contain detailed information on the **Model, Rate & Warranty/Guaranty Period**. The minimum Warranty/Guarantee period will be one year from the date of installation.
8. The rates quoted should be inclusive of all taxes and installation charges. Price is to be quoted along-with Brand name. Rates must be shown in figures as well as in words. In case of any variance between amount quoted in figures and in words, the quotations will be summarily rejected.
9. Quotations for machines of lower configuration than are specified above will be summarily rejected.
10. The quotation should be signed by the authorized person and his/her full name and status should be indicated below his/her signature.
11. The goods should be of Voltas or Hitachi brand only.
12. The quotations should be valid for at least 3 months. The delivery period would be **ten days** from the date of issue of purchase order. For any delay in the supply of goods by the specified date, a liquidated damage of 0.5% of the delivered price of the delayed goods for each week or part thereof subject to a maximum limit of 10% of the delivered price of the delayed goods, will be charged for the number of weeks or part thereof for which the Air conditioner is supplied after the specified date given in the supply order.
13. The Air Conditioners shall be supplied and installed at the premises of Custom House Building.
14. Payment against Bill/Invoice shall be released only after supply/installation and observance of satisfactory performance of the Air Conditioners.
15. Quantity of the Air Conditioners Machine indicated is subject to increase or decrease at the discretion of this office without assigning any reason.
16. **No claim for extra amount over and above the price quoted will be entertained in the name civil works or any other works.** Hence, the interested bidders are advised to inspect the site for installation before submitting their offer. Necessary intimation in such case should be made with competent authority of Customs, Ahmedabad.
17. If any disagreement or dispute arising between the vendor and the Government under or in connection with the terms & conditions, they shall make every effort to resolve amicably by direct informal negotiation, even then, if any disagreement or dispute arising between them shall be settled under the Court of Law within its jurisdiction at Ahmedabad. The resultant contract will be interpreted under Indian Laws.
18. This Office reserves the rights to cancel/accept any/all of the quotation without assigning any reason thereto. Payment will be made as per availability of funds.
