TERMS & CONDITIONS

1. The sealed bid shall be received by this office upto 3.00 PM on 24th April, 2015. Any bid received after the prescribed deadline shall not be considered.
2. The bids shall remain valid for a period of 2 months from the date of receipt of the bid.
3. The rates quoted by the bidders for purchase of old condemned vehicles will be all inclusive and on “As is where is basis”. Any statutory or other charges shall be borne by the bidder. The successful bidder will take possession of the vehicles on a date and time specified by this office and will arrange for transportation of the same on that day at his expense.
4. The vehicles will be disposed off on the basis of highest rate. However, this office reserves the right to withdraw the vehicles from the bidding process in case the quoted price received is less than the reasonable market price.
5. The successful bidder must adhere to the time limit. Failure to deposit the requisite sum before the stipulated date/time, with entail the forfeiture of the contract as well as Earnest Money. After delivery of the vehicles, this office will not be responsible for any damages to the vehicle or person.
6. This office reserves the right to annul the bidding process at any time prior to award of contract including rejection of any or all bids after the same have been received, without thereby incurring any liability to the affected bidder/s or any obligation to inform the affected bidders on the ground of this office’s action.
7. The bidders may physically visit and inspect the bus before putting in their bid. PRO, Customs, Ahmedabad may be contacted for inspection of the vehicles. The inspection of the vehicles may be done from 3 PM to 5 PM of any working day upto 23.04.2015.
8. The vehicle shall be handed over to the successful bidder against 100% deposit of offer/bid value.
9. The payment will be accepted by this office in the form of **Demand Draft of a nationalized bank** only. The payment has to be submitted by the successful bidder within 7 days of the date of delivery of the order otherwise the offer will be cancelled and earnest money shall be forfeited.
