Tender Notice

Office of the Commissioner of Customs, Ahmedabad invites sealed quotations for supplying and installation of LED square panels in the offices of Customs Commissionerate & Chief Commissioner Office, Customs, Gujarat Zone housed in the Custom House building, Near All India Radio, Ashram Road, Navarangpura, Ahmedabad. The details of tender are as under:

The interested parties based in Ahmedabad or their branch at Ahmedabad are requested to send their quotations both Technical and Financial in separate sealed covers addressed to the "Additional Commissioner of Customs, 1st Floor, Office of the Commissioner of Customs, 'Customs House', Navrangpura, Ahmedabad – 380 009. **The last date of submission of quotations is 30.10.2015.** The quotations received after due date will not be considered. The party whose quotation is considered will have to supply and installed the LED square panels within 15 days from the date of receiving of supply order. The tender document are available on the departmental web site www.ahmedabadcustoms.gov.in and www.cbec.gov.in and also with Administrative officer (Adm), Office of the Commissioner of Customs, Second Floor, 'Customs House', Navrangpura, Ahmedabad – 380 009. The Department reserves the right to accept or reject any or all bids without assigning any reasons thereof and not binded to award the contract on the basis of lowest price only.

OTHER TERMS & CONDITIONS:

1. Technical & Financial Bids should be submitted in the separate sealed envelope superscripted with the name of bidder and name of work.
2. Parties are required to quote rate in the financial bid both in figures and words inclusive of all taxes and installation charges on unit basis.
3. The party may quote the rates for one or more than one brands.
4. The completion period will be 15 days from the date of receiving of supply order.
5. The Department is not bound himself to accept the lowest rate or any bid and reserve the right of accepting the whole or part of the bid and bidder shall be bound to perform the same at the quoted rates.
6. The bid shall be typed or written in indelible ink and shall be signed by the bidder or a person or persons duly authorised to sign on behalf of the bidder. All pages of the bid document containing the entries and all corrections or amendments made therein shall be initiated by the person or persons signing the bid.

7. Incomplete bid or bids not fulfilling any of the conditions specified above are liable to be rejected without assigning any reason.
8. In case, the party fails to complete the work within the stipulated period, penalty will be charged @ 10% of the total value of work order or the work order may be cancelled. The Performance Deposit of 10% of the total financial bid is required to be deposited vide Demand Draft in favour of Commissioner, Customs, Ahmedabad. The DD shall be returned to those bidders who are not qualified. However, the Demand Draft of selected bidder shall be returned after the 12 months of Completion of said tender work which includes AMC for said 12 months.
9. The scope of work can be increased or decreased by the Department as per requirement with extension of time, if required.
10. Bids may be submitted either by hand delivery or by post to “ The Additional Commissioner of Customs, 1st Floor, Office of the Commissioner of Customs, ‘Customs House’, Navrangpura, Ahmedabad – 380 009. The tender submitting main envelope should be marked with the “Tender for supplying and installation of LED Square panel.”

GUARANTEE:

The bidder shall warrant that the equipment/materials supplied by them are new, unused and in accordance with the contract documents and free from defects in material with a guarantee for a period of twelve (12) months commencing immediately upon the satisfactory commissioning. The bidder liability shall be limited to the replacement of any defective parts of whole equipment / materials supplied by them.
