NOTICE INVITING TENDER

The Customs Commissionerate, Ahmedabad, invites sealed tenders from different parties from registered recycler/re-processor of e-waste (electronic waste) with Central Pollution Control Board/ State Pollution Control Board for disposal of old and obsolete Computers/Peripherals and other related items (CPUs/Monitors/Printers/Scanners/Key Boards/Photocopier Machines etc.) as detailed in Annexure-B attached to this Tender Notice on “**As is where is Basis**”. Interested bidders are requested to inspect the above items at the Office of the Commissioner of Customs, 2nd Floor, Customs House, Near AIR, Ashram Road, Navarangpura, Ahmedabad-380 009.

General Terms and Conditions :-

1. The bidders may inspect the items on a pre-determined date and satisfy themselves about the items they are bidding for.
2. All the items will be disposed off in one lot to the successful bidder and no part quotation shall be entertained.
3. The items shall be sold to the Highest bidder (H-1). List of items are given at Annexure-B.
4. The Earnest Money Deposit (EMD) of the successful bidder shall be adjusted in the bid forthwith. The EMD of the unsuccessful bidders shall be returned within one month of the auction date without any interest.
5. Items once disposed off to the successful bidders shall not be taken back by the Customs Commissionerate, Ahmedabad, under any circumstances whatsoever.

6. The successful bidder has to make balance payment in the form of Account Payee Demand Draft of a nationalized Bank in favour of Commissioner of Customs, Ahmedabad within two working days.

7. The successful bidder shall be required to lift all the items from the site to his premises within a week time after the payment of the bid amount at his own cost.

8. The bidders should be registered recycler/ re-processor of e-waste (electronic waste) with Central Pollution Control Board/State Pollution Control Board as per E-waste (management and Handling) Rules, 2011.

9. The Commissioner of Customs, Ahmedabad reserves full right to alter or amend any condition of the tender document.

Terms and conditions for Tenders quoted :

1. Quotation letter in sealed envelopes should be addressed to Assistant Commissioner of Customs (P&V) 2nd Floor, Customs House, Near AIR, Ashram Road, Navarangpura, Ahmedabad-380 009 latest by **30.04.2014 by 3.00 p.m.** superscribed by **“Quotation for Obsolete Computers, Printers and related items etc.”** in bold letters.

2. The sealed tender must reach the Office of the Commissioner of Customs, Ahmedabad, before the due date and time otherwise it is liable to be rejected. Tenders received after due date and time due to any reason whatsoever including postal delays shall not be considered.

3. The bid should be quoted both in figures and words. Any overwriting, crossing or erasing in the figure shall not be considered for acceptance of the rates offered by the tenderer.

4. The Commissioner of Customs, Ahmedabad, reserves the right to accept or reject any/all bids without assigning any reason whatsoever.

5. Each page of the tender document should signed by the bidder (s).

6. Incomplete and unsigned quotations are liable to be rejected.

7. For financial evaluation, highest bidder shall be chosen based on the figures quoted in Annexure-A.

8. An Earnest Money Deposit (EMD) of Rs. 3,000/- (Rupees Three Thousand Only) must accompany each quotation. This shall be in the form of DD/Pay order of any nationalized bank in favour of Commissioner of Customs, Ahmedabad. No Cheque/money order/cash shall be accepted.

9. No interest is payable for the Earnest Money Deposit.
