SHOW CAUSE NOTICE (Issued under Section 124 of the Customs Act, 1962)

Based on suspicious movement, the Air Intelligence Officers, Customs, SVP International Airport, Ahmedabad intercepted one passenger namely Jaskaran Singh, (hereinafter referred to as the 'said passenger') holding Indian Passport No. T7275655, aged 26yrs. (D.O.B. 10.04.1994) who had arrived from Bangkok to Ahmedabad by Spice Jet Flight No. SG 086 on 19.02.2020 and was about to exit through the green channel.

- The said passenger was carrying blue coloured suitcase and black and green back pack as his checked in baggage. The said passenger was asked to get his baggage checked into X-ray screening machine located near Customs AIU counter, (opposite to belt no. 4,) in the Arrival Hall of Terminal 2 building of SVP International Airport Ahmedabad. Accordingly, the Baggage of the said passenger were scanned through the X-Ray machine and upon screening of the said baggage, dark colored images had appeared on the screen of the X-Ray Machine, when the baggage were passed through the X-ray machine. On checking the baggage physically, the AIU officer found various small bottles and packets of Medicine/ Medicaments (vial and tablets) with different chemical names which could be seen inside his baggage.
- Whereas, the said passenger was asked to pass through the Door Frame Metal Detector (DFMD) installed at the Arrival Hall. Before the passenger was asked to walk through the Door Frame Metal Detector (DFMD) he was asked to remove all the metallic items worn on his body such as Mobile, Watch, Purse, Wallet, Belt etc (which he readily removed). As he walked through the DFMD loud beep sound was heard. The AIU officers asked Shri Jaskaran Singh about the loud beep sound of DFMD to which he removed one white Rhodium coated Kada from his right hand wrist, concealed in the sleeve of his coat and put in a tray before the AIU Officers. On being asked the passenger accepted and told that the Kada was made of raw gold.
- 4. Whereas, based on primary inference, Government Approved Valuer Shri Kartikey Vasantrai Soni was called by the AIU officers. On testing the said Kada he confirmed that it was of pure gold having purity 24 KT., and submitted his report that the said one gold kada is of pure 24 kt gold weighing 277.600 grams having Tariff value of Rs. 10,15,461/-(Rupees Ten Lakhs Fifteen Thousand Four Hundred and Sixty One only) and the Local Market value of Rs. 11,87,295/-(Rupees Eleven F. No.: VIII/10-62/SVPIA/O&A/HQ/2020-21
