SHOW CAUSE NOTICE

Mr. Junaid Ahmad (S/o Mr. Mohammad Tahir), aged 32 years, residing at Chak No. 11, Tehsil Tanda, Mohalla Hajipura, Tehsil -Tanda, Suar, Rampur, Uttar Pradesh (hereinafter referred to as the "pax No. 1"), arrived at SVP International Airport, Ahmedabad from Delhi by Air India Flight No. AI 019 on 12.02.2020, as a domestic passenger and Mr. Mohammad Javed Akhtar (S/o Mr. Mumtaz Ahmed), aged 38 years, residing at Mohalla-Hajipura, Tanda, Rampur, Uttar Pradesh (hereinafter referred to as the "pax No. 2"), an international passenger, holding Passport No. T9721016, travelled from Kuwait to Ahmedabad in Jazeera Airways Flight No. J9-407 on 12.02.2020.

2. Whereas on the basis of suspicious movements, Mr. Mohammad Javed Akhtar was intercepted by the AIU officers (hereinafter referred to as the "officers") when he was about to exit through the Green Channel area in the presence of panchas for detailed search. The passenger was carrying two bags i.e one black coloured trolley bag and one black coloured back pack bag. He was asked whether he was carrying any metallic substance, to which he denied. He was asked to walk through the Door Framed Metal Detector (DFMD) after removing all metallic substances from his body such as mobile, wallet etc. while he walked through the DFMD, no beep sound was heard indicating there was nothing objectionable/dutiable on his body/clothes. Then, the baggages of Mr. Mohammad Javed Akhtar was scanned one by one in the X-ray bag scanning machine (BSM) located near the green channel counter at terminal 2 of SVPI Ahmedabad, however nothing objectionable was noticed.

3. Meanwhile, a person was noticed lingering around the green channel screening area when the officers were examining Mr Javed Akhtar. On the basis of his suspicious movements, the officers intercepted that person while he was trying to exit through the Green Channel. On being asked, the passenger introduced himself as Mr. Junaid Ahmad who had arrived in Ahmedabad from Delhi through Air India Flight AI 019 as a domestic passenger. However on suspicion, the officers asked him to walk through DFMD. The DFMD sounded an alert beep while the passenger, Mr Junaid Ahmad walked through it. On being asked about the presence of any metallic substance being carried by him, the passenger took out a plastic wrapped packet from the pocket of his
