In exercise of the powers conferred on me by sub-section (a) of Section 8 of the Customs Act, 1962, I, Lalit Prasad, Commissioner of Customs, Ahmedabad, hereby notify the venue of 12th DefExpo-2022, an International Exhibition, to be held at the site of the Helipad Exhibition Centre, Sector-17, Gandhinagar and Ramkatha Ground, Sector 11, Gandhinagar, as specified in the site plan submitted by General Manager(AMD), HAL, Nasik vide letter HAL-NK/DefExpo22/OFF/03 dated 10.02.2022 and mentioned in Column No.1 of the below mentioned **Schedule-A** and **Schedule-B**, respectively, to be the approved Customs area as landing place for unloading of imported goods and for loading of Export goods for the purpose of storage, handling, examination and exhibition of goods imported for DefExpo-2022 and loading of imported goods for the purpose of re-export, from 10.03.2022 to 13.03.2022.

Further, by virtue of the powers vested in me by subsection (b) of Section 8 of the Customs Act, 1962, I notify the area mentioned in Column No. 1 of the below mentioned Schedules, with its limits as specified in Column No.2 and 3 of Schedule A and B, as Customs area for the purpose of unloading, storage, handling, examination and exhibition of goods imported for DefExpo-2022 and loading of imported goods for the purpose of re-export, from 10.03.2022 to 13.03.2022, subject to strict observance of the provisions of the said Act, and instructions issued by the Government of India, from time to time in pursuance thereof.
