**Subject: Warehousing / Storage Charges at SVPI Airport, Ahmedabad & Surat International Airport, Surat – reg.**

Attention of the Passengers, Travel Agents, Airlines and all concern is invited to Board's Notification No. 111- Cus. Dated 08<sup>th</sup> June, 1966 on baggage detained or seized from passenger and subsequently released or returned.

2. Prior to the issue of this Public Notice, the warehousing/ godown charges collected at International Airport, Ahmedabad on the basis of charges printed on the reverse side of the Detention Receipt as mentioned under :

SL No.	Period	Existing charges for Ordinary Packages (In Rs. per package per Week)	Existing charges for Heavy, Bulky and Valuable articles (Electronic goods), requiring special care (In Rs. per package per Week)
i.	For 1 <sup>st</sup> week from the date of detention	Nil	Nil
ii.	For 2 <sup>nd</sup> week from the date of detention	Rs. 20/-	Rs. 30/-
iii.	For 3 <sup>rd</sup> week from the date of detention	Rs. 100/-	Rs. 150/-
iv.	For 4 <sup>th</sup> week and further period from the date of detention	Rs. 200/-	Rs. 300/-

3. It is observed that above mentioned charges have been levied for last so many years and hence, it is felt that the same should be re-examined for enhancement considering limited space available at the airport.

4. Therefore, in exercise of powers conferred under the Passenger's Baggage (Levy of Fees) Regulations, 1966. I, Kumar Santosh, Principal Commissioner of Customs, Ahmedabad hereby notify the revised Charges for Ordinary Packages and Heavy, Bulky and Valuable articles (Electronic goods), requiring special care at Sardar Vallabhbai Patel International Airport, Ahmedabad & Surat International Airport, Surat, with immediate effect, as under:

i.	For 1 <sup>st</sup> week from the date of detention	Nil	Nil
ii.	For 2 <sup>nd</sup> week from the date of detention	Rs. 50/-	Rs. 100/-
iii.	For 3 <sup>rd</sup> week from the date of detention	Rs. 200/-	Rs. 300/-
iv.	For 4 <sup>th</sup> week and onwards from the date of detention, for every week or part thereof.	Rs. 300/-	Rs. 500/-

6. Action to be taken, in terms of this Public Notice, which shall be treated as Standing order by the Officers of this Commissionerate.
