PUBLIC NOTICE NO. 15 /2020

Subject: Waiver of Warehousing / Storage Charges at SVPI Airport, Ahmedabad & Surat International Airport, Surat – reg.

Attention of the Passengers, Travel Agents, Airlines and all concern is invited to Public Notice No. 05/2020 dated 18.02.2020 issued by the Principal Commissioner, Customs, Ahmedabad with regard to notifying the revised Charges for Ordinary Packages and Heavy, Bulky and Valuable articles (Electronic goods), requiring special care at Sardar Vallabhbhai Patel International Airport, Ahmedabad & Surat International Airport, Surat,

2. Keeping in view the situation arising due to outbreak of Corona Virus pandemic in the country, there is likelihood of the situation that passengers are not able to visit the Customs Office at airports for payment of Customs duty and to collect their detained goods.
3. Therefore, keeping in view the exigency due to outbreak of Corona Virus pandemic and in order to facilitate the passengers for clearance of the detained goods, it is decided in the public interest that those goods which are detained on or after 21.03.2020 but before 18.05.2020, at SVPIA Ahmedabad or Surat International Airport, Surat will not attract any Warehousing / godown charges for the period from 25.03.2020 to 18.05.2020 for Ordinary Packages and Heavy, Bulky and Valuable articles (Electronic goods), requiring special care, in terms of Passenger's Baggage (Levy of Fees) Regulations, 1966. However, normal warehousing charges shall be collected for all period / days except for the period from 25.03.2020 to 18.05.2020.
4. Difficulties faced, if any, in implementation of this Public Notice may be immediately brought to the notice of the undersigned.
5. Action to be taken, in terms of this Public Notice, which shall be treated as Standing order by the Officers of this Commissionerate.
